Hence, its various floors are fit from fire safety point of view for occupancy or usage as noted hereunder against each subject to compliance to the conditions as prescribed herein below:

1	Block I-Ground+2 floor	usage	School Educational Group-B (Subdivision=B-1)
2	Block II-Ground+1 Floor	usage	School Educational Group-B (Subdivision=B-1)

CONDITIONS :-

- Fire Prevention and safety measures and appliances, availability of water supplies and means of access there to etc provided in the building or premises, should be maintained by the occupier (5) in best repairs and efficient working condition at all times for use by the occupants or the members of the Fire Service or both in the event of outbreak of fire.
- 2. The setbacks, driveways, entrance gates, exits, staircases, corridors and escape ways should not be changed, obstructed or modified in any way.
- 3. The occupier (5) shall train all staff and occupants periodically to make them well conversant in use and operation of fire prevention and safety measures.
- 4. Fire drills/rehearsals should be organized at least once in six months by involving Local Fire Station.
- 5. Photocopies of this certificate should be framed and displayed at all conspicuous Places in alllobbies/corridors in all floors of all tower/blocks of building/premises.
- The plan needs to be regularized/approved by the competent plan approving authority of the jurisdiction as per govt. Of Odisha Home Department Notification No. 28423/CD Bhubaneswar, dt-20-08-2020 regarding one time relaxation scheme for Odish Fire Service on requirement of structural Fire Safety parameters.
- 7. All other conditions furnished in Odisha Fire Service one time relaxation scheme published vide Govt of Odisha Home Department Notification No. 28423/CD Bhubaneswar, dt- 20-08-2020 will be applicable to the occupancy and applicant will comply on each point accordingly.
- 8. The owner/occupier shall provide any additional Fire Safety measures in future if recommended by the authority concerned in the interest of fire and life safety.
- 9. This Fire Safety Certificate do not absolve provisions made in any other rules and will not automatically immune the provisions made therein.
